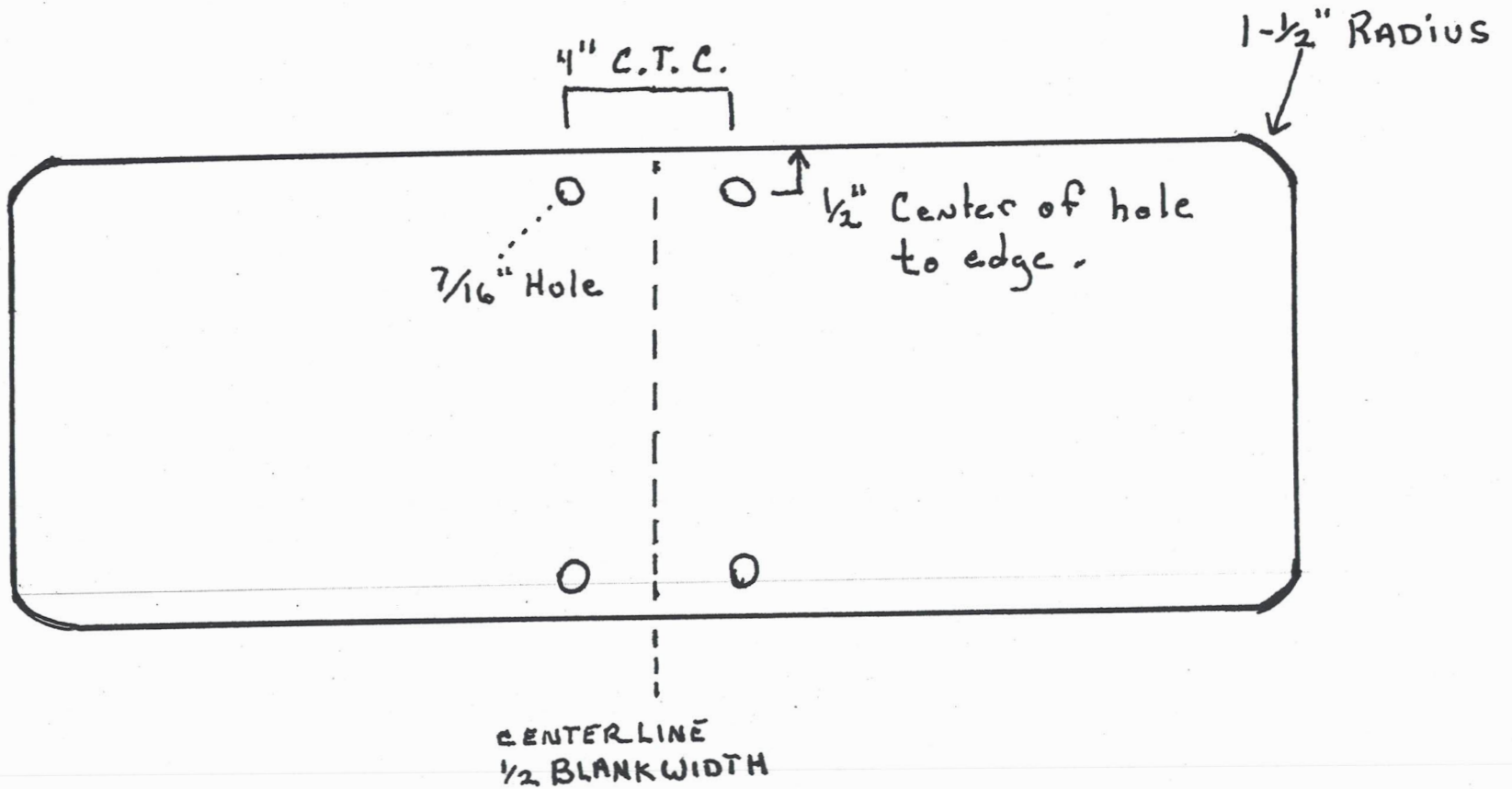

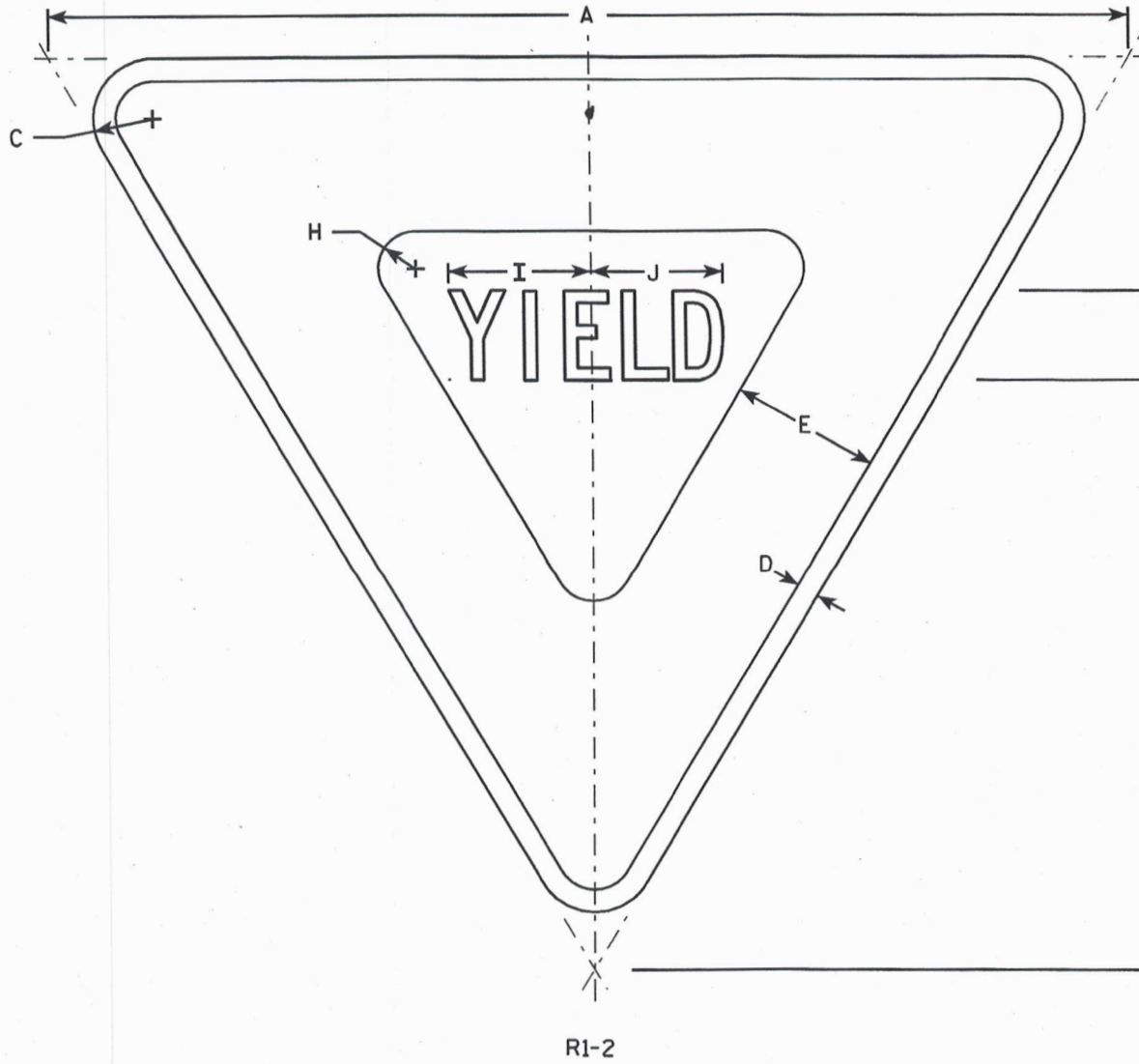

TYPICAL STREET NAME SIGN BLANK



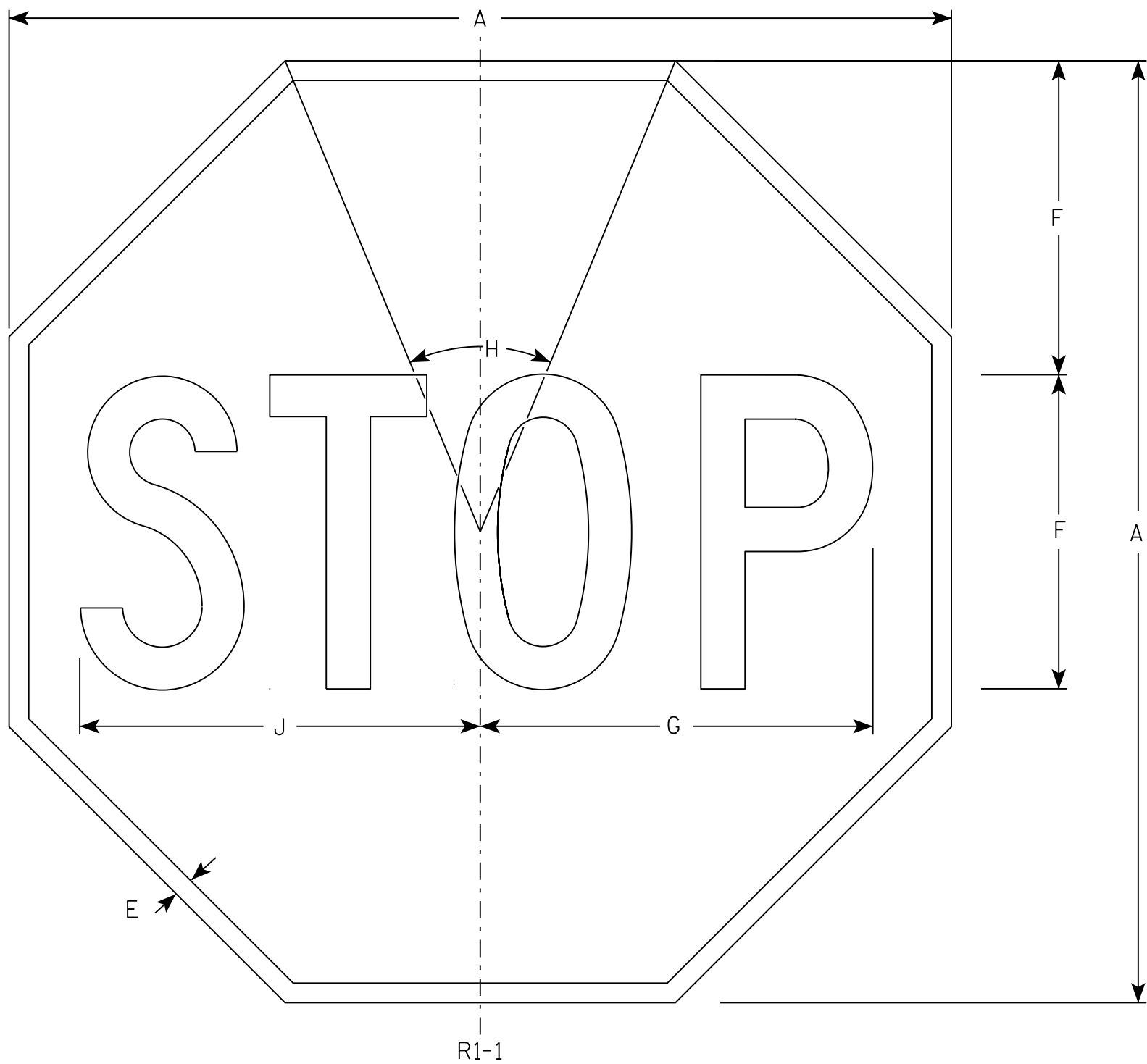
